

**Promotion: Trade Singapore CFDs at 0.07%\***

**Terms and Conditions**

1. Trade Singapore CFDs at 0.07%\* Promotion is applicable to UOBKH existing CFD clients and new clients who open a UTRADE CFD account. UOBKH staff and trading representatives are eligible for this Promotion.
2. The Promotion will be effective from 11th September 2018 to 28 February 2019.
3. Existing clients and new clients will continue to be bound by UOBKH Master Trading Agreement and the terms and conditions of any other agreement(s) that the respective clients have entered into with UOBKH.
4. To be eligible for this Promotion:
  - a. "Existing client" is an individual who has a UTRADE CFD account with UOBKH.
  - b. "New client" is required to open a securities trading account and a UTRADE CFD account with UOBKH.
  - c. The eligible CFD trading account types are: UTRADE CFD individual account, UTRADE CFD joint account and UTRADE CFD corporate account.
  - d. Both the securities trading account and the UTRADE CFD account must be tagged under the same Trading Representative.
5. Under this promotion
  - a. Existing clients with UTRADE CFD accounts and new clients who open UTRADE CFD accounts within the promotional period will enjoy commission rate of 0.07% with minimum commission of SGD15, HKD 88 or USD 11 when they trade SGX shares on UTRADE CFD platform.
