#### a. CDP Internet Service

A secure and convenient online service for investors to access their CDP securities portfolio and e-statements. This service is available by default for all except <u>Corporates</u>, <u>Trustees and Foreigners</u> (without <u>Singpass</u>) who will have to apply. Do note that for Joint Accounts, <u>each</u> account holder will have to submit a completed form. Once you are enrolled on to CDP Internet, you will no longer receive paper statements.

All foreign currencies will be converted to SGD and deposited into your DCS bank account.

#### c. CDP Pre-Settlement Notification (PSN) SMS Service

You will receive SMS notifications of upcoming transactions in your account. All CDP customers are subscribed to this service by default.

#### d. Direct Crediting Service (DCS)

To apply or update DCS, you will need a SGD bank account with one of the following banks in Singapore. For new application, you will receive all foreign currencies (converted into SGD) and SGD dividends and cash payouts in this bank account by default. Please note that this bank account must be registered to the same name and identification number you have provided in your application or update.
