

**BondbloX Promotion**  
**26 September 2022 to 31 December 2022**  
**Terms and Conditions**

1. The UOB Kay Hian ("UOBKH") BondbloX Promotion ("Promotion") is applicable to UTRADE BondbloX clients, Trading Representatives and staff ("Participants").
2. This Promotion will be held between 26 September 2022 and 31 December 2022, both dates inclusive ("Promotion Period").
3. The eligible account type is: BondbloX account.
4. Corporate / Institutional accounts are not eligible for this Promotion.
5. Under this Promotion:
  - a. Only BondbloX purchased within the Promotion Period is eligible.
  - b. Any unique Participant who purchases a minimum of US\$50,000 or S\$50,000 of BondbloX will be entitled to a corresponding US\$400 or S\$400 cash incentive.

*i.e. If you purchase a combination of US\$ and S\$ BondbloX, you will be entitled to cash incentives in US\$ and S\$ on a pro rata basis. For example, purchasing US\$30,000 and S\$20,000 entitles you to a cash incentive of US\$240 and S\$160; purchasing US\$25,000 and S\$25,000 entitles you to a cash incentive of US\$200 and S\$200.*
  - c. Any unique Participant who purchases a minimum of US\$100,000 or S\$100,000 of BondbloX will be entitled to a corresponding US\$1,000 or S\$1,000 cash incentive.
  - d. For every additional US\$100,000 or S\$100,000 of BondbloX purchased, the Participant will be entitled to a corresponding US\$1,000 or S\$1,000 cash incentive.
  - e. The cash incentive is calculated based on the total settlement value of BondbloX purchased (including accrued interests and fees), instead of the face value.

*i.e. If you purchase \$50,000 face value of BondbloX at a price of 90, with accrued interests of \$100 & fees of \$40, it will result in settlement value of \$45,140. This does not meet the minimum purchase amount for any cash incentive.*
  - f. Once the qualifying amount has been met, the cash incentive will be credited to the Participant's BondbloX account in the following month.
  - g. The cash incentive is subject to a cap from the BondbloX Exchange ("BBX")

6. Clients will continue to be bound by UOBKH Master Trading Agreement and the terms and conditions of any other agreement(s) that the respective clients may have entered into with UOBKH.
7. UOBKH reserves the right, in its absolute discretion, to disqualify/reject the client from this Promotion for any reason whatsoever, including upon the occurrence of the following:
  - a. The client failed to pay UOBKH for his/her executed trade(s) and/or has outstanding payment to UOBKH during the promotional period.
  - b. The client is deemed by UOBKH as not in good standing. If the client's account has been suspended temporarily or terminated by UOBKH due to any reason, the client will be disqualified from this Promotion.
8. UOBKH reserves the right to suspend, withdraw or terminate this Promotion at any time for any reason whatsoever and without notice. UOBKH shall not be liable to any person for any loss or damage howsoever arising in connection with the Promotion.
9. All participants in the Promotion expressly and irrevocably permit and authorise UOBKH to disclose, reveal and divulge information regarding their particulars to the parties involved in facilitating the promotional campaign. Further, UOBKH reserves the right to reveal clients' details, to the relevant authorities if it is requested to do so.
10. UOBKH reserves the right in its absolute discretion to add to, delete, vary, modify and/or supplement any one or more of these Terms and Conditions, at any time without prior notice, in such manner as UOBKH shall deem fit, including without limitation, the eligibility of any customer, product and market, the qualifying criteria and the promotional period, without assigning any reasons therefore and without any compensation whatsoever or being liable for any claims, costs, expenses, losses or damages suffered by any person as a result of the aforementioned matters or arising from these Terms and Conditions.

11. The decision of UOBKH on all matters relating to the Promotion and these Terms and Conditions shall be final, conclusive and binding on all UOBKH clients who participate, including, without limitation, any decision on the eligibility of any person or cancellation or suspension of the Promotion and no correspondence or appeal will be entertained.
12. In the event of any inconsistency between these Terms and Conditions and any marketing material relating to this Promotion, these Terms and Conditions will prevail.
13. These Terms and Conditions shall be governed by the laws of Singapore. UOBKH clients participating in the Promotion will irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a participant of this Promotion shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these Terms and Conditions.
