

UOB Kay Hian Hong Kong Market Promotion 2019

1 July 2019 to 31 August 2019

Terms and Conditions

- 1. The UOB Kay Hian ("UOBKH") Hong Kong Market Promotion 2019 ("Promotion") is applicable only to clients trading online with UOBKH.
- 2. This Promotion will be from 1 July 2019 to 31 August 2019.
- 3. Only online trades on Hong Kong Exchange are eligible.
- 4. The eligible securities account types are: retail individual account and retail joint account.
- 5. UTRADE Edge, UTRADE Plus, UTRADE CFD, Corporate/Institutional, UOBKH trading representatives and staff accounts are not eligible for this Promotion.
- 6. Under this Promotion:
 - a. Clients are required to execute at least 3 trades to enjoy the rebate. The Promotion entitles each Client a maximum of 3 free trades, capped at a maximum rebate of \$\$50 ("the Rebate"), regardless of the number of trading accounts he or she has.
 - b. The rebate will be in the form of bonus points. The equivalent of 1800 bonus points will be credited in the following month and are valid till 31 December 2020.
 - c. New clients with no prior or pre-existing business dealings with UOBKH who open a cash or margin trading account with UOBKH will also enjoy 1 month free Hong Kong real time streaming price when they execute at least 3 online Hong Kong trades during the Promotion period.
 - d. The free 1 month Hong Kong real time streaming price will be activated in the following month.
- 7. This Promotion is not valid in conjunction with other UOBKH promotions that may be running at the same time, i.e., if a client has enrolled in other UOBKH promotion that is held between 1 July 2019 and 31 August 2019, he will be excluded from this promotion.
- 8. Prevailing terms and conditions on Rewards and Bonus Points apply.
- 9. Clients will continue to be bound by UOBKH Master Trading Agreement and the terms and conditions of any other agreement(s) that the respective clients have entered into with UOBKH.
- 10. UOBKH reserves the right, in its absolute discretion, to disqualify/reject the client from this Promotion for any reason whatsoever, including upon the occurrence of the following:
 - a) The client failed to pay UOBKH for his/her executed trade(s) and/or that he/she has outstanding payment to UOBKH during the promotion period.
 - b) The client is not in good standing. If the client's account has been suspended temporarily or terminated due to any reason, the client will be disqualified from this Promotion.
- 11. UOBKH reserves the right to alter, terminate or suspend this Promotion for any reason whatsoever.
