

New Thailand Market Promotion 2023
1 March 2023 to 31 August 2023
Terms and Conditions

1. The UOB Kay Hian ("UOBKH") New Thailand Market ("Promotion") is only applicable to UTRADE Equities clients trading online.
2. This Promotion will be held between 1 March 2023 and 31 August 2023, both dates inclusive ("Promotion Period").
3. Only online trades (Securities) via UTRADE Online Platforms (Web or Mobile App) are eligible.
4. The eligible securities account types are: retail individual account and retail joint account.
5. UTRADE CFD, Leveraged Products, UTRADE Robo, BondBlox, Corporate/Institutional, UOBKH trading representatives and staff accounts are not eligible for this Promotion.
6. Under this Promotion:
 - a. Clients are required to execute **at least 2 trades within ONE calendar month** during the Promotion Period to be eligible for SET Live Prices in the subsequent[^] month and 150 Bonus Points*.
 - b. 2 trades in point 6a refer to **at least 2 contract notes** generated from client's online trades.
