

Singapore Depository Receipts (SDRs) Promotion

19 June 2023 to 31 August 2023

Terms and Conditions

1. The UOB Kay Hian ("UOBKH") Singapore Depository Receipts ("Promotion") is only applicable to UTRADE Equities clients trading online.
2. This Promotion will be held between 19 June 2023 and 31 August 2023, both dates inclusive ("Promotion Period").
3. Only online trades (Securities) via UTRADE Online Platforms (Web or Mobile App) are eligible.
4. The eligible securities account types are: retail individual account and retail joint account.
5. UTRADE CFD, Leveraged Products, UTRADE Robo, BondBlox, Corporate/Institutional, UOBKH trading representatives and staff accounts are not eligible for this Promotion.
6. Under this Promotion:
 - a. Only the first 100 Clients who execute trade(s) in Thai SDRs listed on SGX using their UTRADE account during the Promotion Period will be entitled to receive trade rebates of up to SGD 50 for their SDR trades.
 - b. The below table is for illustration purposes only and UOBKH reserve the rights to award the rebate based on clients' standing with UOBKH and eligibility.

- c. The 3 Thai SDRs listed on SGX eligible for this Promotion are:

 - CP All TH SDR (TCPD)
 - PTT Exploration & Production TH SDR (TPED)

UOBKH clients participating in the Promotion will irrevocably submit to the non-exclusive jurisdiction of the courts of Singapore. A person who is not a participant of this Promotion shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these Terms and Conditions.
