


Trade the Magnificent 7 Promotion 4 November 2025 to 3 December 2025 Terms and Conditions

- 1. The UOB Kay Hian ("UOBKH") Trade the Magnificent 7 Promotion ("Promotion") is applicable only to clients who trade online with UOBKH.
- 2. This Promotion will be held from 4 November 2025 to 3 December 2025 ("Promotion Period").
- 3. Only online trades in the US Magnificent 7 stocks *Apple, Amazon, Alphabet, Meta, Microsoft, Nvidia, and Tesla* will qualify for lucky draw chances.
- 4. Eligible trades must be executed in the Magnificent 7 stocks through UTRADE, UTRADE X, or UTRADE Delta accounts during the Promotion Period.
- 5. Corporate/Institutional, UOBKH trading representatives and staff accounts are not eligible for this Promotion.
- 6. All existing and new clients are eligible to participate in this Promotion. The eligible securities account types are: retail individual account and retail joint account.
- 7. Complimentary US live prices are available only to Non-professionals.
- 8. Under this Promotion:
 - a. Clients stand a chance to win various prizes through a lucky draw. To qualify, a client must make at least one (1) online trade (buy or sell) in any of the US Magnificent 7 stocks Apple, Amazon, Alphabet, Meta, Microsoft, Nvidia, and Tesla during the Promotion Period.
 - b. Eligible trades must be executed in the Magnificent 7 stocks listed on the US market via UTRADE, UTRADE X, or UTRADE Delta accounts.
 - c. Each trade in a Magnificent 7 stock earns 1 lucky draw chance.
 - d. Bonus: New clients whose trades are executed via UTRADE X accounts will earn 2x lucky draw chances.
 - i. New clients are defined as those who open a UTRADE X account during the Promotion Period via instant account opening, and do not have any existing UTRADE accounts with UOBKH.

- e. There is no cap on the number of chances a client can earn. The more trades made, the more chances accumulated.
