

Unit Trust Flash Promotion 15 October 2025 to 14 November 2025 Terms and Conditions

- 1. UOB Kay Hian ("UOBKH") Unit Trust Flash Promotion ("Promotion") is only applicable for clients transacting in Cash and SRS.
- 2. This Promotion will be held between 15 October 2025 and 14 November 2025, both dates inclusive ("Promotion Period"). All qualifying transactions must be completed by 14 November 2025.
- 3. All new and existing clients are eligible for the promotion.
- 4. Under this Promotion:
 - a. The first 50 clients to make a minimum S\$10,000 Cash or SRS purchase of any unit trust will each be rewarded S\$288 cash ("Reward").
 - Bonus: If the investment is made in any of the three highlighted UOBAM funds below, clients will instead receive a total of \$\$388 cash (an extra \$\$100 on top of the base reward).
